<p>詳題</p> <p>本規則旨在為規程 15.6 (j)「各學院院務會的成員組織須納入：由在有關學院全時間修讀香港中文大學學位認可課程的學生互選產生的學生一名」及規程 15.6A(1)「學院院務會的學生成員由教務會行使其絕對酌情權決定的方式及任期選出」規定選舉安排，並就規程 15.6A (2) 至 (4) 項指示經由上述選舉產生的學生成員的權責。</p>	<p>Long Title</p> <p>These Rules are to govern all matters of election according to Statute 15.6 (j) “1 student elected by, and from among, full-time students of the Faculty pursuing approved courses of study for a degree of the University.” and Statute 15.6A (1) “A student member elected under paragraph 6(j) is to be elected in such manner and for such period as the Senate may in its absolute discretion determine.” , and to indicate the authorities and responsibilities of the student members elected from the above elections in accordance with Statute 15.6A (2) to (4).</p>
<p>第一條 簡稱</p> <p>本規則可引稱為《學院院務會全時間學生成員選舉規則》。</p>	<p>Section 1 Short Title</p> <p>These Rules may be cited as “Election Rules of Student Members of Boards of Faculty”.</p>
<p>第二條 學生成員選舉</p> <p>就每一學院而言，須由在有關學院全時間修讀香港中文大學學位認可課程的學生（包括本科生及研究生）互選產生選出一人，成為該學院院務會的學生成員。</p>	<p>Section 2 Election of the Student Members</p> <p>One student from each Faculty of the University shall be elected by, and from among full-time students in that Faculty pursuing approved courses of study for a degree of the University (including undergraduate and postgraduate students) to serve as the Student Member of the respective Faculty Board.</p>
<p>第三條 學生成員任期</p> <p>學生成員任期一年，由三月一日至翌年二月最後一天止。</p>	<p>Section 3 Term of Office of the Student Members</p> <p>Elected Student Members hold office for one year, from the first day of March to the last day of February of the following year.</p>
<p>第四條 學生所屬學院之劃分方法</p> <p>一、 全時間本科生按其修讀主修課程所屬學院分屬學院。</p> <p>二、 全時間研究生，按其研究範圍或所屬研究學部分屬學院。</p> <p>三、 就此選舉而言，任何不隸屬單一學院的學生，又沒有在上述條文提及者，得由選舉委員會經諮詢教務長及有關學院院長後予</p>	<p>Section 4 Determination of Faculty Assignment</p> <ol style="list-style-type: none"> <li>1. Full-time undergraduate students are assigned to a Faculty according to the major programme they each belong to.</li> <li>2. Full-time postgraduate students are assigned to a Faculty according to their respective research fields or Graduate Divisions.</li> <li>3. All undergraduate and postgraduate students studying approved courses of study for a degree in the University are eligible to become electors in the election of Student Members and, if nominated according to the criteria stipulated by these Rules, are eligible to become candidates in the election of the Student Member of their respective Faculty Board.</li> <li>2. If during his/her expected term of office, any student who is known to graduate, or undergo overseas exchanges with accumulated duration exceeding half of his/her remaining term of office, he/she is no longer eligible to be a candidate for the election.</li> </ol>

A Faculty Board Student Member shall cease to be a student member if he/she ceased to be a full-time student of the Faculty concerned due to reasons such as change in Faculty, graduation, or withdrawal of study from the University.</li> <li>2. A Faculty Board Student Member shall cease to be a student member upon his/her departure from Hong Kong for overseas exchange the accumulated duration of which will exceed half of his/her remaining term of office.</li> <li>3. Student Members whose studies are temporarily suspended are not subject to these rules.</li> </ol>

The Election Committee does not belong to any organizations inside or outside the University. The Committee is composed of representatives appointed by the representative organizations through the invitation of the Registrar each year.</p> <p>2. The Election Committee holds office for one year, from the first of September to the last day of August of the following year. If a member of the Committee no longer holds the position which he/she held at the time of appointment, he/she shall cease to be a member of the Committee.</p> <p>3. Once appointed, the student members of the Election Committee cannot be dismissed or replaced unless with the consent of the Election Committee, approval of impeachment, or loss of his/her position held at the time of appointment. For the purpose of this rule, the appointment organization shall inform the Election Committee in writing, if its representative is to be dismissed or replaced; such notice shall be duly signed by the Chair of the appointment organization, outgoing member(s) and the substituting member(s) and approved by the Election Committee by circular vote or at a meeting. The notice shall be deemed approved if it does not receive objection from more than two-thirds of the members of the Election Committee.</li> <li>2. The resignation of any student member of the Election Committee requires the approval of the Committee and shall be delivered to his/her appointing organization for review. The concerned appointing organization shall appoint another student representative to fill the vacancy.</li> <li>3. The termination of appointment of any student member of the Election Committee requires the issuance of an annulment of appointment unless his/her term of office ends.</li> </ol>

The Election Committee shall be entitled to make decision by circular vote after its first meeting convened by the Registrar.</li> <li>2. Unless receiving written objection from two members by means of correspondence or email, the Convener may put any matter into circular vote.</li> <li>3. The Secretary shall assist in the execution of the circular vote; and shall be responsible for the related liaison work.</li> <li>4. A circular vote may be arranged by means of correspondence or email, with a minimum duration of 72 hours.</li> </ol>

If there is more than one candidate standing for the election, the candidate receiving the highest number of votes shall be considered elected. If two or more candidates tie for the highest number of votes, a second ballot shall be held. In all cases, the election shall only be deemed valid if one-tenth or more of the full-time students of that Faculty have voted in the election.</p>
<p>第十五條 院務會學生成員辭職</p> <p>院務會學生成員如欲辭職，須向其所屬院務會、香港中文大學研究生會(如屬研究生)及香港中文大學學生會(如屬本科生)提出，院務會須公告該學院全體同學。</p>	<p>Section 15 Resignation of Faculty Board Student Member</p> <p>Should any Student Member of a Faculty Board decide to resign, he/she shall put this forward to the Faculty Board concerned, the Postgraduate Student Association (for postgraduate student), and Student Union (for undergraduate student) of the University. The concerned Faculty Board shall publicly notify all students of the Faculty.</p>

<p>第一條 學生成員權責</p> <p>一、 學生成員為代表其學院全時間學生參與院務會工作之學生代表。</p> <p>二、 學生成員須在院務會中反映學生意見，並諮詢學生意見。</p> <p>三、 學生成員因執行學生成員職務而招致之開支，包括但不限於文具、印刷、交通等開支，選舉委員會酌情決定償付方式。</p> <p>四、 學生成員須於每次院務會會議之後兩星期內向所屬學院同學提交工作報告，並附書面工作報告予研究生會及大學學生會。</p> <p>五、 學生成員於任期結束後一個月內向所屬學院同學提交全年工作報告，並附書面工作報告予研究生會及大學學生會。</p> <p>六、 在大學學生會代表會主席邀請下，學生成員須列席或出席香港中文大學學生會的會員大會、聯席會議和代表會會議。</p> <p>七、 在學院院會或系會邀請下，學生成員須列席其會議。</p> <p>八、 學生成員須遵守本規則。</p> <p>九、 學生成員須遵守有關保留事項的規定。</p>	<p>Section 1 Authorities and Responsibilities of the Student Members</p> <ol style="list-style-type: none"> <li>1. The Student Members are student representing the full-time undergraduate and postgraduate students of their respective faculty in participation of the work of the respective Boards of Faculty.</li> <li>2. The Student Members shall consult students' opinions and deliver them in the Faculty Boards.</li> <li>3. Expenses incurred by the Student Members in the execution of their duties, including but not limited to expenses on stationery, printing, and transportation, are payable at the Election Committee's discretion.</li> <li>4. The Student Members shall submit their working reports to the students of their respective Faculty within two weeks after each meeting of the Board of Faculty, and enclose their written working reports to the Postgraduate Student Association and the University Students Union.</li> <li>5. The Student Members shall submit their annual working reports to the students of their respective Faculty within one month after the end of their terms of office, and enclose their written working reports to the Postgraduate Student Association and the University Students Union.</li> <li>6. Upon invitation of the Chairperson of the Representative Council of the University Students Union, the Student Members shall sit in or attend the general meetings, joint meetings and Representative Council meetings of the University Students Union.</li> <li>7. Upon invitation of the Faculty Association or the Department Association, the Students shall sit in their meeting.</li> <li>8. The Student Members shall act in accordance with these rules.</li> <li>9. The Student Members shall observe the rules governing their participation in reserved areas of business.</li> </ol>

2. To be a nominated candidate, an eligible student must be nominated by a proposer and a seconder, and have the nomination form countersigned by at least twenty other students who are eligible electors in the election. Any eligible elector shall only sign on one nomination in a single election, in one of the following roles as a proposer, seconder or countersigning elector. A candidate must not be the proposer, seconder or countersigning electors for his/her own nomination.

3. Members of the Election Committee are forbidden from being candidates, proposers, seconds or countersigning electors.

4. Nomination form can be obtained from the Election Committee and the duly completed form must be submitted to the organization/unit designated by the Election Committee before 12 noon of the day the nomination period ends.

5. The nomination period is from the first of October to the first school day after the fifteenth of January of the following year. If tropical cyclone signal number 8 or above or the black rainstorm warning signal is issued on the day the nomination period ends, the end of the nomination period shall be postponed to the school day after the signal is cancelled.

6. Nomination form must be filled in in traditional Chinese or English, including basic personal information, and information of the proposer, the seconder, and the countersigning electors. Numbers are not subject to this limit.

7. Information of the proposer, the seconder, and the countersigning electors must not include any error, otherwise the nominee shall not be qualified as a candidate.

8. In case of any repetition, errors in information, or omission of the countersigning electors, that countersignature shall be considered invalid. The nominee must still have valid countersignatures of no fewer than twenty full-time students after removal of invalid countersignatures; otherwise the nominee shall not be qualified as a candidate.

9. All forms cannot be altered after

5. Chair of the consultation sessions are entitled to determine whether the question raised by the audience

12. Personal attacks, defamation, distorting facts or false statements are not allowed.

13. Each audience is allowed to ask no more than two main questions, and one follow-up question after each main question.

14. Chair of the consultation sessions may refuse non-members of University Students Union / Postgraduate Student Association to address the session.

2. The Election Committee members, notwithstanding their positions in their appointing organizations, shall act individually with the objective of ensuring the fair and smooth execution of the election instead of defending their appointing organizations.

In case of any misconduct or negligence of duty in the duties of the Election Committee on the part of the Committee members, Returning Officers, executing members appointed in accordance with these Rules, the Election Committee or the appointing organization of the concerned Election Committee member is entitled to, depending on the degree of severity,

a. pass a bill of regret and publicly announce to all staff members and students of the University;

b. pass a bill of impeachment.

4. The impeached Election Committee Member shall be handed over to the judicial body of his/her appointing organization for a verdict.

5. In the process of the hearing, the Election Committee shall issue an order of suspension that lasts until the verdict is issued.
